

Kids' Bike Parade Parent/Guardian Waiver and Release of Liability

In consideration of the minor Participant/Attendee being permitted to participate in the Kids' Bike Parade, I, as the parent or legal guardian of the minor Participant/Attendee, agree to the following:

I acknowledge that participation in a bike parade involves inherent risks, including but not limited to: falls, collisions with other participants or objects, road conditions, weather conditions, and other hazards that may result in injury.

On behalf of the minor Participant/Attendee and myself, I voluntarily assume all risks associated with participation in this event and hereby waive, release, and discharge the Event Organizer, Event Director, sponsors, volunteers, officials, contractors, the hosting municipality, and all other persons or entities associated with this event (collectively, the "Released Parties") from any and all claims, liabilities, damages, or causes of action arising out of or related to the minor Participant/Attendee's participation. On behalf of the minor Participant/Attendee and myself, I knowingly and voluntarily assume all risks, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASED PARTIES or otherwise, to the fullest extent permitted by law.

I certify that the minor Participant/Attendee is physically able to participate safely in this event and will follow all event rules and instructions. I understand that I am responsible for supervising the minor Participant/Attendee before, during, and after the event unless otherwise specified.

I consent to emergency medical treatment for the minor Participant/Attendee if necessary and accept full responsibility for any associated medical costs.

I further agree to INDEMNIFY, DEFEND, AND HOLD HARMLESS the Released Parties from any and all claims, liabilities, damages, or causes of action (including reasonable attorneys' fees and costs) arising out of or related to my participation in the event, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASED PARTIES.

I agree that the minor Participant/Attendee will use appropriate safety equipment, including a properly fitted helmet.

I grant permission for the minor Participant/Attendee's name and likeness to be used in photographs, video recordings, or other media for legitimate promotional purposes without compensation.

I understand that all registration fees are non-refundable and that the event may be modified, postponed, or canceled due to conditions beyond the organizers' control.

By registering the minor Participant/Attendee for this event, I confirm that I have read, understood, and agree to this waiver and release on behalf of myself and the minor Participant/Attendee.

This agreement shall be governed by the laws of the State of North Carolina. This Waiver and Release of Liability shall be binding upon the heirs, executors, administrators, successors, and assigns of the minor as well as myself. If any provision of this Waiver is held invalid or unenforceable, the remainder shall

continue in full force and effect. I understand that this Waiver is intended to be as broad and inclusive as permitted by North Carolina law.
